#### COURSE DESCRIPTION

This course presents an introduction and overview of public health and epidemiology, including the distribution and correlates of illness in the population and current efforts to prevent and control risk factors that contribute to morbidity and mortality. Additional topics include public health issues that face the primary care provider including TCM practitioners

#### LEARNING OBJECTIVES

By the end of this course, the student will be able to:

- Identify the basic principles of public health
- Describe social and behavioral determinants of health and understand how health outcomes are measured
- Provide examples of current public health issues and concerns
- Differentiate between public health and medicine and how the two disciplines can work together
- Select and apply appropriate theories to public health and TCM practice
- Describe how public health principles can affect TCM practice
- Incorporate health communication & education and promotion principles in TCM practice
